## Contributors

GEOFFREY CANTOR is Professor Emeritus of the History of Science at the University of Leeds and Honorary Senior Research Fellow at University College, London. His publications on science and religion include *Michael Faraday: Sandemanian and scientist* (1991) and *Quakers, Jews, and science* (2005). He co-authored *Reconstructing nature* (1998) with John Brooke and co-edited *Jewish tradition and the challenge of Darwinism* (2006) with Marc Swetlitz. He is currently researching the role of religion in the Great Exhibition of 1851.

THOMAS DIXON is Senior Lecturer in History at Queen Mary, University of London. He has pursued three related strands of research: the history of theories of passions and emotions; the history of debates about 'altruism', especially in Victorian Britain; and, more generally, the history of relationships between science and religion. Previous publications include *From passions to emotions: The creation of a secular psychological category* (2003), *The invention of altruism: Making moral meanings in Victorian Britain* (2008), and *Science and religion: A very short introduction* (2008).

NOAH EFRON chairs the Program in Science, Technology and Society at Bar-Ilan University. He is President of the Israeli Society for History and Philosophy of Science and a member of the executive committee of the International Society for Science and Religion. He has been a member of the Institute for Advanced Study in Princeton, the Dibner Institute for History of Science and Technology at MIT, and a Fellow at Harvard University. He is the author of *Judaism and science: A historical introduction* (2007).

JAN GOLINSKI is Professor of History and Humanities at the University of New Hampshire, USA. He is the author of *Science as public culture:*
